    - Budget Monies of \$189,000 was deposited July 3
    - Andy's Transmountain grant of \$5000 came in on July 12, 2025
  - \$76,309.87 in Fire truck account as of today
  - \$219,057.84 1-year non-redeemable Term Deposit – June 16, 2025- Coming up for renewal June 16, 2026.
  - \$36,154.24 in BRVFD account as of today
  - Budget and drilled down numbers for July 25, 2025.

- Blue River Improvement District Fire Department Regulations Bylaw No. 167, 2025 additions.

  - Should a trustee or fire department member should have to attend court for any reason they will receive compensation. Govt rate per KM as well as a half day rate of \$100 And full day rate \$200 plus expenses and kms.
