#### 5. UNFINISHED BUSINESS

- Street lighting
  - LED Options will be available in the next year.
    - Tom completed the audit and have emailed it back to BC Hydro
    - Check on LED's Tom to look at the spreadsheet and pick the proper wattage so we can fix the other lights – Tom still to double check spreadsheet.
      - We have not receive confirmation of the selection that the Improvement District would like for the replacement of the existing High Pressure Sodium light over to LED lights. Street light out on Sesame Street – track end

  - Jamie Viera is no longer in charge of the garbage and recycling. Martin is still the contact.
  - No collection complaints recently.
